## **Proposed Library District Public Hearing Multnomah County Commission July 31, 2012**

The Leagues of Women Voters of Portland and of East Multnomah County support a public library system that upholds the principles of intellectual freedom and the public's right to know. We support the library as a basic community service with an assured, stable and adequate source of funding.

The Leagues urge you to refer creation of the library district to the November ballot. Voters should be given the opportunity to approve a district with a permanent rate that will provide funding sufficient to support all library needs. The current practice of relying on temporary local option property tax levies for a major portion of the system's budget is unacceptable, especially in light of the overwhelming support voters demonstrated for their libraries during the May election.

We acknowledge the impact a new library district will have on local taxing jurisdictions and understand their concern. Rather than objecting to creating a stable source of funding for our libraries, however, the League encourages elected officials to consider calling for a statewide conversation about the property tax system. The current debate about how to fund our libraries is only one indication that there is room for improvement.

Again, we fully support referring the library district to the November ballot. Thank you for considering our comments.

**Sometimes it is necessary to consider tough realities.** This is one of those times.

**We need effective public relations.** We cannot, for example, depend upon the efforts of the Multnomah Friends of the Library to design campaigns to remind everyone of the importance of libraries. The Friends are nice people. It's fun to party with them. But they seem to be largely a social group. There is apparently no one in the group who wants to spend hours designing truly effective communications. There is apparently no one in the group who even thinks that is important.

**Libraries support the best in us.** It seems obvious to many that the U.S. is going through a period of decline. To help improve our lives, our entire nation needs the efforts of thoughtful, knowledgeable, caring people. They are supported by having access to the best thinking. That thinking is available in libraries.

**In the early 1900s, Andrew Carnegie gave his money to start 1,795 libraries.** Those libraries are one of the reasons the U.S. has experienced decades of prosperity. We have had better leaders because those who thought they might like to be leaders were able to educate themselves. We have had social progress because those who wanted improvements could understand the thinking of others who felt the same way. (Wikipedia: List of Carnegie libraries in the United States)

**Libraries help in numerous ways.** Recently, a French friend called from France to tell me of his strong interest in a book about graphic design by a French-American author. I went to the Multnomah County Library web site and visited WorldCat. WorldCat listed only one copy of the book in the French library system. That copy is not available for loan. Multnomah County Library got a copy for me from a U.S. library. During an online video call, I paged through the book for my friend, putting the pages in front of my video camera.

My wife Adriana is from Brazil, a country that almost never has snow. Brazilians are often fascinated by snow. Adriana finds it relaxing to read about arctic expeditions, in books from the library.

Adriana is studying how to make publications using a new version of Adobe InDesign software. Adobe has not been particularly good about documenting its own product. Adriana says the best help she has gotten has been from a book she found in the Multnomah County Library.

Any person who fails to comply with reasonable rules of conduct or who creates a disturbance may be asked or required to leave and upon failure to do so becomes a trespasser.
